

Terms & Conditions: Conference & Events Points Promotion

These Terms and Conditions apply to the Conference & Events Points Promotion ("Promotion").

1. Promoter

This promotion is conducted by DBay Nominee Pty Ltd ABN 58 761 269 297 trading as InterContinental Sydney Double Bay, located at 33 Cross Street, Double Bay, NSW, Australia, 2028 ("Promoter").

2. Promotion Period

The promotion opens at 12:00am (AEDT) on 18 March 2026 and closes at 11:59pm (AEDT) on 31 December 2026 ("Promotion Period"). Entries received outside this period will not be accepted.

3. Eligibility

Entry is open only to individuals who:

- are 18 years of age or older;
- are residents of Australia
- make a qualifying booking in accordance with these Terms & Conditions.

The following are **not eligible** to enter:

- employees, contractors, officers, and immediate family members of the Promoter;
- employees and contractors of InterContinental Hotels Group (IHG) and its affiliated or managed hotels;
- agencies, suppliers, or partners associated with this promotion.

By entering, entrants confirm they are Australian residents and meet all eligibility requirements. Even if the entrant is submitting an entry as part of a corporate event booking, the prize will be awarded to the individual entrant personally, not the company.

4. Qualifying Booking Requirement

To be eligible to enter, entrants must:

- Be a new conference or events booking made with the Promoter;
- Be contracted during the Promotion Period (on or after 18 March 2026);
- Have a confirmed total booking value of AUD \$30,000 or more, excluding audiovisual hire;
- Be held during the 2026 calendar year; and
- Submit a valid creative entry during the Promotion Period.

Existing, transferred, or previously contracted bookings are not eligible.

Each qualifying booking receives one (1) entry, unless otherwise determined by the Promoter.

5. How to Enter

Eligible entrants must submit an original creative response of 200 words or fewer answering:

“Describe your ultimate dream holiday. Be creative! Tell us where you’d go, what you’d do, and why it’s special.”

Entries must be the entrant’s original work and must not contain unlawful, misleading, defamatory, or infringing content. Incomplete or non-compliant entries may be deemed invalid.

Even if the entrant’s submission is associated with a corporate event booking, the entry must be submitted by the individual, who will be the sole recipient of any prize won.

6. Game of Skill

This promotion is a game of skill. Chance plays no part in determining the winner.

Entries will be judged on merit against the following criteria:

- Originality and creativity (40%)
- Clarity and structure (30%)
- Engagement and overall quality (30%)

Judging will be conducted by a panel appointed by the Promoter on 10 January 2027. All decisions are final and no correspondence will be entered into.

7. Prize

There is **one (1) prize**:

- 1,000,000 IHG One Rewards points (estimated value approximately AUD \$6,000)

8. Prize Conditions

- The prize will be awarded to the individual entrant who submits the winning entry and is the personal property of that individual.
- Where an entry is submitted in connection with a corporate event booking, the entrant confirms that they have obtained any necessary approvals or permissions from their employer or organisation to participate in this promotion and to personally receive the prize if awarded.
- The Promoter will not be responsible for any internal policies, restrictions, or approvals required by the entrant’s employer or organisation.
- Points will be credited to the winner’s personal IHG One Rewards account. If the winner does not have an account, they must create one to claim the prize.

The winner will be determined by the judging panel on 10 January 2027 and notified via email within 14 days of judging. If the winner does not claim the prize within 7 days, the Promoter may select an alternative winner based on the original judging criteria.

10. Intellectual Property

By submitting an entry, entrants grant the Promoter a non-exclusive, royalty-free, perpetual licence to use, reproduce, publish, and communicate the entry for promotional and marketing purposes.

11. Privacy

Personal information will be collected and handled in accordance with the Privacy Act 1988 (Cth) and the Promoter's Privacy Policy available at [Privacy Policy | InterContinental Sydney Double Bay](#)

12. Liability

To the extent permitted by law, the Promoter is not responsible for any loss, damage, or injury suffered in connection with the promotion or acceptance or use of the prize. Nothing excludes rights that cannot be excluded under Australian Consumer Law.

13. General

The Promoter reserves the right to verify entries and disqualify any entrant who breaches these Terms & Conditions or tampers with the entry process. The Promoter may modify, suspend, or cancel the promotion where reasonably necessary.

14. Governing Law

These Terms & Conditions are governed by the laws of Australia, with the courts of New South Wales having exclusive jurisdiction.
